NOTICE OF THE FIRST ENROLLMENT DEADLINE

for enrollment of students in the first year of the **Professional study of Dental hygiene**
in the academic year 2020/21

FIRST APPLICATION DEADLINE: **5th June – 5th July 2020**

The Faculty enrolls 20 (twenty) candidates, as follows:

- 20 (twenty) self-financing students - full-time study with a full teaching fund, and the costs of studies are borne by the students themselves.

Applications are made exclusively online, through the information system, www.upis.unsa.ba.

Informations about candidates who completed high school in Sarajevo Canton during registration are linked to data in the EMIS system.

Candidates who have completed high school according to international programs in the Sarajevo Canton are required to scan and upload documents that are not in the EMIS system.

Candidates who have completed high school outside Sarajevo Canton are required to scan and upload the following original documents:

- Certificates of completed grades of secondary school completed in Bosnia and Herzegovina for a period of four years, ie appropriately recognized documents for candidates who have not completed secondary school in Bosnia and Herzegovina (if the documents are in the equivalence procedure, a certificate is attached as proof that the equivalence procedure is ongoing) ,,
- diploma of completed high school,
- birth certificate,
- Certificate of Citizenship,
- documents relevant for determining the number of points according to the criteria

During one application period, candidates will be allowed to change the study program three times.

Applications submitted through the eUNSA system after the deadline set by the Competition, as well as incomplete applications, will not be considered.

Ranking of candidates and admission of students to the first year of study will be done depending on the number of points that the candidate reaches based on:

- general success,
- success in the mother tongue and subjects important for the relevant study: Biology, Physics and Chemistry,
- results achieved in competitions in subjects relevant to a particular study: Biology, Physics and Chemistry,
- excellent (5.0) success in all subjects and exemplary behavior during the entire secondary education.

The right to participate in the Competition under equal conditions have:

- citizens of Bosnia and Herzegovina and foreign citizens who have completed a four-year secondary school in Bosnia and Herzegovina;
- candidates who have completed secondary school outside Bosnia and Herzegovina, and who, after the recognition or equivalence procedure, have been determined to have completed adequate education for further education;
- Candidates who have completed a four-year high school according to international programs approved by the competent ministry.

The selection of candidates will be based on the Decision on Criteria and Criteria for Determining the Order of Admission of Candidates for Enrollment in the First Year of the First Cycle and Integrated Study at the University of Sarajevo in the Study 2020/2021 year, which is an integral part of the Competition, as well as individual criteria established for the evaluation of grades from subjects relevant to the relevant study program, and evaluation of the results of entrance exams if they are provided.

The preliminary ranking list of all accepted and registered candidates is published via the eUNSA information system as well as on the notice board / website of the faculty (under the code that the candidates received during registration) after verification by the Commission, no later than two days after the deadline. submission of applications for the appropriate application deadline of the Competition.

Candidates have the right to object to the preliminary ranking list within three days from the day of its publication, on which the Faculty Council is obliged to make a decision within three days. The decision of the panel on the objection is final.

After the expiration of the appeal deadline, the Commission is obliged to enter and verify the results of the accepted complaint in the eUNSA system.

The final ranking list of candidates who have acquired the right to enroll in all statuses is published on the eUNSA information system as well as on the notice board / website of the faculty.

Within seven days from the day of publication of the final ranking list, the candidate who has exercised the right to enroll is obliged to submit the originals of the uploaded documents to the faculty and make the enrollment; otherwise it is considered that he has given up enrollment in the study program for which he applied, and the right to enroll is acquired by the next candidate from the final ranking list who has met the conditions for enrollment, until the approved quota is filled.

After the expiration of seven days from the announcement, the faculty publishes the revised final ranking list of candidates via the eUNSA information system as well as on the notice board / website of the faculty, and the next candidates from the revised final ranking list who have met the conditions have the right to enroll in the next five days. for enrollment.

After the publication of the ranking list, candidates who have the right to enroll in the I (first) semester of the study year 2020/21 will be subsequently notified of the date of enrollment.
