FIRST ENROLLMENT DEADLINE FOR ENROLLMENT OF STUDENTS IN THE FIRST YEAR OF PROFESSIONAL STUDIES I CYCLE "DENTAL HYGIENE" IN THE ACADEMIC YEAR 2022/23

## FIRST APPLICATION DEADLINE: June 13th - July 1st 2022

No entrance exam will be taken for enrollment in the study program at the Faculty of Dentistry with clinics.

University of Sarajevo - Faculty of Dentistry with clinics announces a competition for enrollment in the first year of the professional study Dental Hygiene, for:

- 50 (fifty) full-time self-financing students, study costs are borne by the student.
- 50 foreigners out of the total number of students.

Applications for the competition for enrollment in the first year of professional for foreign candidates are made at Student Service at Faculty of Dentistry with clinics.

Preliminary ranking list of candidates who have acquired the conditions for enrollment in the first year of professional studies will be published on July 4th.

SECOND APPLICATION DEADLINE: August 28th – September 9th 2022 - No entrance exam will be taken

Preliminary ranking list of candidates who have acquired the conditions for enrollment in the first year of profssional studies will be published on September 19th.

## DOCUMENTATION REQUIRED FOR APPLYING FOR THE COMPETITION FOR ENROLLMENT IN THE FIRST YEAR:

Candidates who apply for the professional study program of Dental hygiene will submit their documents directly to the Student Service, with the obligation to register on the online enrollment system <a href="https://www.upis.unsa.ba">www.upis.unsa.ba</a>

Candidates who finished high school outside the Sarajevo Canton, as well as candidates who finished high school in the Sarajevo Canton and are not in the EMIS system, are required to submit following original documents:

- (1) Data on candidates who finished high school in Sarajevo Canton during registration are linked to data in the EMIS system, and are required to upload a Certificate of Citizenship and Birth Certificate.
- (2) Candidates who have completed high school according to international programs in the Sarajevo Canton are obliged to scan and upload documents that are not in the EMIS system.
- (3) Candidates who have completed secondary school outside Sarajevo Canton, as well as candidates who have completed secondary school in Sarajevo Canton and are not in the EMIS system, are obliged to scan and upload the following original documents:
- a) Certificates of completed high school classes completed in Bosnia and Herzegovina for a period of four years, or appropriately recognized documents for candidates who have not completed high school in Bosnia and Herzegovina (or confirmation as proof that the recognition / equivalence process is ongoing)
- b) high school diploma,
- c) birth certificate,
- d) certificate of citizenship,
- e) documents relevant for determining the number of points according to the criteria, as well as documents relevant for proving the status of belonging to the category of children of martyrs and fallen soldiers, children of war invalids, children receiving war awards and decorations and children without both parents,
- f) Foreign nationals: proof of knowledge of b / h / s language if they apply for a study conducted in b / h / s language,
- d) Citizens of BiH, ie candidates coming from the states that emerged from the disintegration of the SFRY: proof of knowledge of the English language, if the study program is conducted in English.

## RANKING OF APPLIED CANDIDATES:

Ranking of candidates and admission of students to the first year of study will be done depending on the number of points that the candidate wins based on:

- 1. general success,
- 2. success in English language and subjects important for the study program Dental hygiene: Biology, Physics and Chemistry,
- 3. results achieved in competitions in subjects relevant to the study program Dental hygiene: Biology, Physics and Chemistry,
- 4. excellent (5.0) success in all subjects and exemplary behavior during the entire secondary education
- 5. other points defined in Article 21 of the Competition for enrollment of students in the first year of study
- 6. priority of choosing the study program.

The right to participate in the Competition under equal conditions have:

- citizens of Bosnia and Herzegovina and foreign citizens with completed high school in four years in Bosnia and Herzegovina;
- candidates who finished high school outside Bosnia and Herzegovina, and for whom it is after the procedure recognition or equivalence determined to have completed adequate continuing education schooling;
- Candidates who have completed a four-year high school according to international programs approved by the competent ministry.

The selection of candidates will be based on the Decision on criteria and criteria for determining the order of admission of candidates for enrollment in the first year of study at the University of Sarajevo in the academic year 2022/2023, which is an integral part of the competition, as well as individual criteria for evaluating grades. relevant to the relevant study program.

Preliminary ranking list of all accepted and registered candidates is published through the eUNSA information system as well as on the notice board / website of the faculty (under the code that the candidates received during registration) after verification by the Commission, no later than two days after the deadline for applications. application deadline of the Competition.

Candidates have the right to object to the preliminary ranking list within three days from the day of its publication, on which the Faculty Council is obliged to make a decision within three days. The decision of the panel on the complaint is final. After the expiration of the appeal deadline, the Commission is obliged to enter and verify the results of the accepted complaint in the eUNSA system. In the case of an accepted objection which affects the ranking of candidates within the approved quota, the quota shall be extended by the number of candidates whose objections have been accepted.

The final ranking list of candidates who have acquired the right to enroll in all statuses is published on the eUNSA information system as well as on the notice board / website of the faculty.

When there are several candidates on the unique list of candidates in the enrollment quota who achieve the same number of points, all candidates in the status for which they are applying are accepted, and the list is expanded by that number of candidates.

Within seven days from the day of publication of the final ranking list, the candidate who has exercised the right to enroll is obliged to submit the originals of the uploaded documents to the faculty and make the enrollment; otherwise he is considered to have given up enrollment in the study program for which he applied.

When a certain number of candidates from the countries of origin are included in the envisaged enrollment quota after the disintegration of the SFRY, the list of accepted candidates is expanded by that number of candidates for citizens of BiH up to 4% of candidates in the status for which they are applying.

The amount of participation in the prices of services and tuition fees of the University of Sarajevo, and the faculties and academies within it is determined by the Decision of the Government of Sarajevo Canton on giving consent to the amount of participation in prices of services, enrollment and other study costs Official Gazette of Sarajevo Canton ", number: 19/09, 31/12, 36/12, 4/15, 15/15, 16/18 and 21/18).
